



Global Catalytic Ministries **2024 Form 990 - Program Accomplishments Summary**

To Whom It May Concern:

Global Catalytic Ministries (GCM) respectfully submits this summary of program accomplishments in conjunction with our 2024 Form 990 for the fiscal year ending December 31, 2024.

Global Catalytic Ministries is a disciple-making organization committed to catalyzing movements of Jesus among every nation, tribe, and tongue, with a strategic focus on the most unreached and persecuted regions of the world. Throughout 2024, the ministry experienced significant expansion in global reach, leadership development, and field-based disciple-making initiatives.

Global Expansion and Reach

In 2024, GCM expanded active ministry access from 48 countries in 2023 to 71 countries in 2024. Ministry initiatives now operate across the Middle East, Africa, Europe, Asia, North America, and Latin America.

The regional coaching initiative grew substantially, increasing access and live engagement across Africa, Europe, South America, North America, and the Middle East. Total lifetime participation in online training programs reached 14,596 individuals equipped in disciple-making methodologies.

Training and Leadership Development

In 2024, GCM strengthened its global training infrastructure through:

- Launch of the Disciple-Making Boot Camp, enrolling over 800 students globally.
- Ongoing regional live coaching across multiple continents.
- Weekly accountability and prayer-based discipleship groups.
- Development and expansion of digital e-courses and training resources.
- A three-day leadership retreat focused on prayer, strategic alignment, and global vision.
- A nine-week Pride and Humility teaching series delivered through online platforms.
- Production of over 70 digital teaching resources to support disciple-making efforts.

Graduates of these programs initiated new discipleship groups across the United States and internationally, including Mexico, Egypt, Georgia, and other regions.



Field Impact in Restricted and High-Risk Regions

GCM continues to prioritize indigenous leadership and contextualized disciple-making in areas marked by persecution and instability.

Myanmar

- 108 home churches planted
- 287 baptisms
- 55 team trainings in church planting and disciple-making
- 27 village outreaches
- 12 main trainers equipped in Luke 10 church planting, contextualization, and Discovery Bible Study methods

Despite civil unrest and persecution, disciple-making initiatives continued to expand in both rural and conflict-affected areas.

Pakistan

- 251 individuals trained in disciple-making initiatives, including leadership development and community outreach efforts.

Middle East (including Saudi Arabia and Israel/Palestinian Territories)

- Ongoing underground disciple-making initiatives in highly restricted environments.
- First 6 baptisms in Mecca's 1400-year history, one of the most religiously restricted cities in the world.
- Cross-cultural ministry efforts among Israelis and Palestinians, emphasizing reconciliation and gospel engagement.
- Expanded access into Gaza through strategic relationships and campaign efforts.

Throughout 2024, Global Catalytic Ministries expanded global access, strengthened indigenous leadership, multiplied training initiatives, and deepened engagement in some of the most spiritually and politically complex regions in the world.

This summary reflects the organization's ongoing commitment to disciple-making, leadership development, and sustainable movement growth among unreached and persecuted communities worldwide.
